

## **International Student Agreement**

By signing this form, I certify that I understand and accept the following conditions and agree to abide by them. As a condition of my admission, I agree to the following:

- 1. I understand that I am required to pay <u>ALL Tuition and Fees</u> by the designated payment deadline EACH semester. If I do not pay by the deadline date, I understand I will be unable to enroll in my classes. Failure to be enrolled in classes means, I am in USCIS violation.
- 2. I will have available sufficient funds for tuition, fees and living expenses for each year I study at Los Angeles City College. I recognize that the cost of living is high, that financial aid from the university is not available and that international students are not permitted to work off campus without the approval of CPT. There may be limited on-campus employment; however, LACC does not guarantee employment. My chances of working on campus the I understand that not all students who look for work will get a job. I understand that my sponsor will be expected to cover my expenses for the entire duration of my schooling.
- 3. I am responsible for understanding and abiding by the rules and regulations of being on a student visa in the United States.
- 4. I agree to enroll full-time (12 units) for each Fall and Spring semester at LACC. All 12 units must be completed with grade (i.e. A, B, C, D, or F) incomplete (IINC) or Withdrawals (W's) do not apply toward the 12 unit requirements.
- 5. I agree to enroll only in up to 3 units Online/Distance Ed. courses each semester
- 6. I agree to enroll in courses programmed for me by the Academic Counselor.
- 7. I understand that the instructor may exclude me from class without notice for unexcused absences or tardiness.
- 8. I will maintain at least a "C" (2.0 GPA average. I will meet with counselor, my professors, consult with the Designated School Official and participate in tutoring if I am at risk of not passing all of my classes.
- 9. I agree to purchase the LACC Student Health Insurance Plan as a condition of admission and continued enrollment. Exemptions maybe granted to students with governmental insurance, though these students must obtain a qualifying letter from their government.
- 10. I will arrive on or before the reporting date on my Form I-20.
- 11.I will attend the mandatory Orientation at the beginning of my first semester at Los Angeles City College or a hold will be placed on my LACC account. I will then have to resolve this hold issue with International Student Office in order to register for classes.
- 12. I understand that I must report any changes in name, address, telephone number and major to my International Student Advisor within 10 days of change.
- 13.I declare that all the information I have submitted for my application is true, correct and complete. I understand I will comply with all of the requirements as stated on this agreement. I understand that falsification of any information will jeopardize the issuance of a Form I-20 and/or may result in Los Angeles City College revoking its decision to enroll me as a student.
- 14. If I am a transfer student from another U.S. college/university or Language School, I will bring an up-to-date, current copy of my Form I-20 to International Student Services upon my arrival to Los Angeles City College.
